## **BEEFWOOD - Stud 2176**

Beefwood is operated by Brett and Ashlee White, along with their four sons: Thomas, Henry, Edward, and Alistair.

In 2007, Brett and his father, registered the Satellite Santa Gertrudis (2085) prefix after purchasing foundation females from Fishington and Wave Hill studs. The sale of the family property in 2021, resulted in the cessation of the Satellite stud prefix. This led to Brett taking over the management of the female herd. The herd was relocated from Warwick to Wallumbilla and transferred to the newly established Beefwood Santa Gertrudis prefix.

We have a strong commercial focus, aiming to produce easy doing structurally correct cattle, with an emphasis on productivity, fertility, and longevity. Over the years sires from Fishington, Glenn Oaks, Rosgar, Dundee and more recently Munnabah and Diamond H studs, have been added to achieve these goals. Further females have been added from Kilcock, Bullamakinka, Pinnaroo and Glenn Oaks studs. The Beefwood herd is run alongside The Bank Shorthorn stud, in conjunction with a commercial Santa Gertrudis Shorthorn cross enterprise. Brett and Ashlee also operate the WLS Fitting service.

This year's sale draft have been vet checked, motility, morphology and pregnancy tested by Breeding & Wellness Vet Services. Fertility guaranteed and vaccinated for 7 in 1, 3 Day, Vibrio and 3 Germ blood. We are very proud to donate the sale proceeds of Lot 68 to support rural mental health; in honour and memory of our dear friend and fellow passionate Santa Gertrudis breeder Sharon Seawright.

## **CARNTYNE - Stud 1556**

Carntyne Santas is a family operated business owned by Ben & Carly Evans and their children Grace, Oliver & Isla. Their rural enterprise, Tullamore Park Pastoral Co runs around 1500 breeders over 5 properties expanding over the Roma, Surat & Injune districts. The Stud maintains approx. 150 stud females each year for the purpose of breeding bulls for private paddock sales, the Heartland Sale in Roma, as well as for the use in their own stud and their commercial Santa Gertrudis and Brahman herds.



The primary focus is on the overall herd fertility and quality, and by selecting genetics which will continually improve and compliment the current attributes of the existing herd. A lot of emphasis has been placed on using genetics that will produce highly fertile, sound, thick, easy-doing progeny that will fatten easily, have good constitutions and placid temperaments.

Of recent years the Stud's focus has been on selecting suitable and specific Carntyne females for the annual AI programs.

Current AI & stud sires include a number of Carntyne 'S' bulls; Watasanta Landrover (P); Dangarfield Abdul (P); Rosevale King; Waco Chancellor (P); Dangarfield Second-To-None; Waco Odessey (P); Diamond H Quilpie; Dangarfield Zelot (P); Triple S Q20; Triple S Q10; Warenda Quicksilver (P); Dangarfield Tornado & Moongana Nudge (P).

Carntyne heifers are joined as yearlings to homebred Santa bulls. They are expected to calve unassisted and reconceive each year. Any female that does not return a PTIC result annually, or is a poor milk producer, is culled from the herd. Additionally all bulls are semen tested annually, and any sire whose progeny returns poor conception rates and other bad genetic traits, are also culled. A pelvic measurement of all replacement heifers and bulls is an important annual practice that has

all but eliminated maiden calving problems in the herd as only those with adequate measurements are retained for breeding.

Carntyne cattle are handled by men/women/children with horses, motorbikes, on foot and with dogs (border collies and sausage dogs!)

All Carntyne bulls are bred and prepared for a long working life. They are not pampered or overfed to be the biggest, heaviest bulls at sale age, but the focus is more on good conformation, growth, soundness, fertility, and overall constitutions. Carntyne's aim is to have the best genetics behind them to breed bulls to boost and compliment your breeding program to get the best 'bang for your buck'.

Carntyne Stud will not have any bulls on offer at the Heartland sale this year due to lack of available bull numbers. However, we welcome all enquires and interest in our cattle, and appreciate all feedback, positive / negative, from clients on their previous bull purchases.

We look forward to caching up with you all at the Heartland Sale 2025.

## CG SANTAS - Stud 2155

CG Santos is operated by Steven, Sharon & Cooper Goodhew and was established in 2019, based at "Laurbrook" Roma.



Our Stud is based on females purchased from Santa Park, Moongana, Allendale & Pinaroo as well as our own S & S Bar females. We have placed a large emphasis on fertility and temperament in our herd.

2024 saw CG Santos around the show rings for the first time with CG Unity taking out Reserve Junior Champion Female at Clifton Show and then placing 2nd in a very strong class at Beef 2024. Thank you WLS Fitting Service for Showing our cattle.

This year we offer 1 Classified S Bull which has been vaccinated for 7 in 1, 3 day and Vibrio as well as semen and morphology tested. We look forward to a successful Heartland Bull Sale for 2025.

## CHILGERRIE HILL - Stud 991

"50 YEARS"

This year we celebrate 50 years of breeding Santa Gertrudis cattle.

Santa Gertrudis were introduced in the 1960's when Adam's grandparents purchased bulls from Rosevale and Yarrawonga.

Stud cows were purchased in 1974 from dispersal sales and Kabunga West & later by Adam & Karen from Gyrranda, Brookside, Rosevale, Florando & Mt Ty.



Chilgerrie Hill Santa Stud was formed in 1975 by Adam's parents. The family have now been breeding Santa Gertrudis for over 60 years and the Stud has been going for 50 years this year. In 1998 Adam and Karen took over the stud and run it and a commercial herd.

Our children and grandchildren are all involved in the property and the stud. We have started showing cattle again as the grandkids are all keen to have a go. High pregnancy rates and excellent temperament's and fat weaners. Our steers are sold to the same family every year and they always comment on the quietness of our weaners and come back every year so we must be doing something right. Some of our resident sires include; Dangarfield Firecracker (Yarrawonga Megabyte), Cooida Touch Judge, (Moongana Kansas),

Doorabeeba Sitka (Hardigreen Park Victory). This years Sale Bulls are by the following sires & this will be the last year of their progeny; Chilgerrie Hill 99J (Diamond H Questman), Spring Creek Cassidy (Bullamakinka Gladiator), Bunda N22 (Cardona Organic), Glenalbyn Pegasus (Burrumurra 188).

## DARR CREEK - Stud J331

Darr Creek began when our parents Glen & Kathleen purchased us a stud female each at the Raytek dispersal sale in 2013. We already had classified Santa bulls on hand which were being used in our family's crossbreeding program, and later purchased females from Oakdale, Rosevale and Pinaroo studs. Mitch was also extremely fortunate to have won two lovely heifers at junior camps donated from Rosevale and Glen Oaks studs. We are continuing to focus on building up a strong herd of quality, fertile, easy doing classified females.



Darr Creek Santas are located north of Jandowae in a mixture of forest and brigalow country. This year's sale bulls have been vet checked, semen and morphology tested by Kelly Ag Morphology Services in Dalby, vaccinated for 3 Day, 3 Germ, 7 in 1 and Vibrio.

We look forward to seeing everyone at the sale in 2025.

## DUNROBIN - Stud 1489

Dunrobin Stud was started by Roy and Dorothy Harrison with cows upgraded from a commercial herd. In 2017 Dunrobin stud was purchased by Brendan, Paula, Rowan and Lucy Harrison and has been relocated to Bungaringa Mitchell, running in conjunction with our commercial herd.

## GLENVIEW - Stud 558

In 1972, Glenview Stud was registered by Graeme and Margaret Ferguson of Nobby. The stud commenced with the purchase of a sire from Old Hidden Vale and females from Talooona, Myola and Laidlaw studs.

Since the stud commenced, our females have largely maintained a strong King Ranch, Yarrawonga and Waco bloodline, with many sires being purchased from those studs.

Glenview runs approximately 50 breeders, with the stud now run by our son Scott, and his wife Wendy. My breeders run alongside the Glenn Oaks and Wave Hill females, using sires from Diamond H, Goolagong, Yarrawonga and Waco, including Renegade, Red Foo, Leopard, Attorney, H1304, L596, Eland. All of these are sires of this year's sale bulls.

Glenview has consistently sold bulls for above average prices for use in commercial herds as well as selling successful show bulls to studs including Barbados, Granville, Frampton. These bulls have bred well for their purchasers.

This year's sale draft have been vaccinated for 7 in 1, vibrio, 3 Day and blooded for 3 germ blood.



## JAZMAREE – Stud 2164

Jazmaree Santas was Registered in 2020 by Peter & Sharon Seawright. We have for many years been passionate Santa Gertrudis breeders and have over the last few years been developing our Santa Gertrudis Stud herd. We are based at “Comet Downs” Injune. To give you some idea of our passion for the breed, we purchased our first commercial heifers from Sharon’s parents Rod & Nancy Cloherty “Reben Downs” Injune.

They have been breeding Santas for over 50 years, Their Sires over the past years have been purchased from Swan Hill, Yarrowonga, Waratah, Diamond H, Moongana, Bullamakinka, Talgai, Glenview and more.

We have invested heavily in the breed with the purchase of stud females and classified stud sires from a large range of genetics and have also upgraded selected purebred females to S Bar into our stud.

Sale Bulls will be vet checked, Morphology tested, scanned, vaccinated for 7in1,Vibrio, 3 Day and Blooded for 3 germ blood.

## MURGO – Stud 1468

Murgo Santa Gertrudis Stud began in the mid-1980s in northern N.S.W. We bred over from Herefords to avoid recurring problems with calving and pink-eye. At the same time, we admired the natural “doing” ability of these beautiful big, cherry-red cattle and how well they adapted to their environment.

We moved to Queensland in 1993, finally settling at “Maroona”, Mungallala in 2003. From here, we have successfully continued to develop our stud by buying sires from such studs as Dangarfield, Pinaroo and Rosevale and using our own Murgo 630, Murgo 703 and Murgo 218.

This year we are offering three stud bulls and two herd bulls. All are polled or poll scur. The first two stud bulls, Murgo Victor 354 (P) and Murgo Vanguard 356 (P), are both by Dangerfield Emulate E231(P) (Dangarfield Zonta Z109(PS)). Emulate was purchased from Dangarfield in 2022 for \$22,000.

The third stud bull, Murgo Vaughan 377 [P] is by Murgo Samson 218 (Dangarfield Yumchuck Y246(PS)). Samson is a big, meaty bull with plenty of thickness throughout.

The first herd bull, Murgo Venture 358 (PS), is by Dangarfield Emulate E231(P) and the second, Murgo Vernon 379(P) is by Dangarfield Carbine C177 (P), purchased in 2020 for \$11,000.

Our bulls are grassfed until two months before Sale Day. They then go onto a light ration of XLR8 pellets. This means they are ready to go to work immediately after purchase.

Murgo bulls display the typical Santa Gertrudis traits we continue to breed for – dark coat, good bone, width, muscle, growth, depth and weight for age. A quiet temperament is a must. Records show a propensity for longevity too!

Note - this year, 2025, we have purchased sires from Rockingham, Denngal and Benelkay Studs and are looking forward to their progeny later in the year.



## OAKDALE – Stud 1159

The Oakdale Stud was founded at Boonah in 1980. It was relocated to Chinchilla in 1993.

Present sires in use are Oakdale Longbow, whose sons have sold to \$42,000 and averaged \$15,000. Longbow is our leading sire, he had a very successful short show career.

Rosehill Rhys was purchased as second top price at the Big S Sale in 2022. Oakdale Phantom was retained in our stud as a standout son of Dangarfield Anzac. This year's draft of sale bulls have been finished on oats.

## PINAROO – Stud 1150

The Pinaroo Stud No. 1150 was started by Peter and Robin Cupitt in 1982. Together they enjoyed over 40 years of successful breeding, showing and selling of stud cattle. Sadly, the passing of Peter in early 2022 resulted in the winding up of their partnership and an End of Era female sale in March 2023.

However, a decision was made to retain the stud name and the purebred commercial female herd and some proven stud sires, which will be used to grade up the herd under the ownership and management of Cameron and Deborah Boot, who have worked with Peter and Robin for over 25 years.

## ROCKY VIEW – Stud 2169

Rocky View is a small stud located in the Pilton district on the Darling Downs, established around seven years ago by Ben and Michelle Eastwell. Also, we have a small commercial herd of Santa cross breeders and run an off-farm business – Eastwell Construction.

The stud's bloodlines range from various genetics, Oakdale, Pinaroo, Dangerfield, Talgai, Tyndale and Dunlop to name a few, we are slowly building our stud herd up.

## SPRING CREEK – Stud 1833

The Spring Creek Stud is operated by Andrew and Angela Doering and family.

Currently, the breeding herd is run on properties in the South Burnett, with numbers exceeding 400 classified females and still growing.

Our herd is completely DNA and gene tested, to guarantee the pedigrees of our cattle and aid decision making within our breeding program.

The following Sires are represented in our 2025 Heartland Sale offering;

Canowindra Tennessee T148 (PP). Purchased for \$105,000, the top price at the 2021 Canowindra sale, he is a PP bull that exhibits an exceptional rump, smooth tailbone, a broad and long tail, and stands on strong bone with a very correct structure. His impressive spring of rib, strong muscling and depth of flank is complimented by a soft dark coat, with an impeccable temperament. Tennessee is producing a very consistent quality draft of offspring, both bulls and females.



Warrillee N19 (P) was purchased for the top price at the 2020 Brisbane Valley Santa sale. He was selected for his strong muscling and correctness of structure, and is producing offspring carrying these traits and exhibiting excellent breed character.

Warrillee N19 (P) was the sire of our 2023 Heartland top price bull, Spring Creek Theodore T606 (P) Spring Creek Neptune N414 (PS), is an exceptional son of Bullamakinka Gladiator G52, and grandson of the renowned Canowindra Gold Edition. He was retained for his length and volume, breed character and temperament, but also to maintain this bloodline in our herd as it has consistently produced quality progeny for us.

Our success in the steer competition at the 2024 Sydney Royal Easter Show, with 5 out of our team of eight led steers awarded carcase medals, (Spring Creek Uber Eats winning first place in a class of 27), confirms that we are on the right track with our breeding program, and the quality of our herd is producing a high standard of commercial product.

At this year's 2025 Sydney Royal Easter Show, we bred and supplied the Schute Bell Charity steer – Spring Creek Vector V92 (P). Vector was prepared by the students at P.L.C. Armidale, and was sold at auction for \$18,000, with all the proceeds donated to The Victor Chang Heart Research Institute.

Further success with our steers this year includes class placings of first, second and third at the Wingham Beef Week Carcass Competition and a fifth placing in a massive class of 60 in Class 6 of the 2025 Callide Dawson Carcass Competition. We have also exhibited prime cattle at local country shows, being awarded Champion Grassfed Steer and Heifer respectively at the 2025 Gin Gin show, culminating with our steer winning Champion Beast of Show.

Our selection criteria focus firmly on commercial traits. Fertility, growth, muscling, constitution, conformation and particularly temperament, are all vital when selecting stud stock. We also use a balance of poll and horned sires, in order to maintain breed type and the sought after qualities Santa Gertrudis are renowned for.

## WHITALBY – Stud 1242



Operated by Cameron & Rosie Drynan and family, the Whitalby Santa Gertrudis stud is situated at "Bogong" south west of St George. Our breeding aim is to produce structurally correct and commercially productive cattle, with a strong focus on temperament and fertility. The stud herd is run predominantly on buffel and mulga country, where they are bred to survive and maintain production throughout dry spells. Young bulls are grown out in the paddock with only a light lick supplement, prior to sale prep. Some of our current sires include Whitalby Earnest (P), Bullamakinka N518 (PP), Warendra P30 (P) and Hayleigh 1181 (P) and exciting new future sire Hardigreen Park Zeb (P). We endeavour to stay up to date with market demands, whilst maintaining a true Santa Gertrudis type.

## IMPORTANT NOTICE

All bids shall be treated as offers made upon the following Terms and Conditions of Sale and all persons present are admitted to attend the sale on the basis that they have notice of these Terms and Conditions.

1.
